# **Bikes: Science on Two Wheels**

More than 40 bicycle, historic and modern, form the centerpiece of "Bikes: Science on Two Wheels" at the Kalamazoo Valley Museum September 22—January 6.

The bicycle, or some version of it, has been around since the nineteenth century, and it is still a popular form of transportation today. Bikes are a part of our everyday life from childhood through adulthood, but we don't often notice the science behind this wonderful invention. In the exhibit BIKES: Science on Two Wheels, we get to see over 40 variations of bikes from the late 1800's to modern times, including the classics and oddities. Through a dozen interactives, visitors are able to engage in the science, history, design, and art behind the bicycle!

On display are four sections that take us on a tour and show us the cultural impact the bicycle has had on our world!

**The Origins**: Features the evolution of, and the precursors to, the modern bicycle.

**The Classics**: Showcases bicycles from the 1930's to the late 1970's.

**The Sport Bikes**: Focuses on multi-speed bikes and the change in technology.

**Oddities and Offshoots**: Displays examples of "not so ordinary" bikes.

This exhibit is organized by the Carnegie Science Center in cooperation with the Bicycle Museum of America.

# **President's Update**

As you all have read TCBA has a budget deficit. This deficit is due to declining revenue from DALMAC which is TCBA's primary source of income. That said, for the past few years TCBA has spent funds more to support membership, promote safe, social bicycling and create community partnerships than we have received from DALMAC. The TCBA Board has asked for, and received input from members, on how we could proceed to make some budget cuts to reduce this deficit. We have decided to make some changes that minimally will impact us all.

-TCBA will stop printing and mailing the "Chainwheel Chatter" effective January 2018. (The Board is considering how to identify the handful of TCBA members who do not have Internet access and, therefore, might be unable to access a digital copy of the Chainwheel Chatter.) We will continue to produce the "Chainwheel Chatter", and this will be available online for your easy access.

- -TCBA will eliminate our telephone service.
- -TCBA is also making several reductions in our Board spending. These cuts may reduce some aspects of "services" provided to our members but Events will continue like the Picnic, Holiday Party and Appreciation Dinner.
- -TCBA Board has worked very hard over the last several months to make these decisions, so that our mission of "Promoting safe, social bicycling since 1972" may continue another 48+ years. We believe making these small changes now, will allow TCBA to continue as a leader in this area, in Michigan, and in the United States.

This year's 5-day tour features routes on roads and/or trails all from the convenience of a single camping location, **John Gurney Park Campground in Hart, Ml.** 

The tour will begin on **Wednesday**, **July 10 and end on Sunday**, **July 14**, **2019**. Camping will be available starting on Tuesday, July 9 after 3 PM at no additional charge. On Sunday, riders will return to the campground in time to pack and leave by 2 PM.

Daily routes will vary between 25 and 60 miles, with various options. The Sunday ride will be a shorter variety to allow for returning to camp, shower and check-out by 2 PM.

This is **primarily a tent camping tour**, with provision for some RV's (for an extra fee).

Included in the basic fee are tent camping facilities, route maps & cue sheets, SAG service, and meals. Dinners Wednesday through Saturday, and breakfasts Thursday through Sunday are provided and served in a pavilion at the campground. There will be group campfires with S'mores and munchies in the evenings, as well as light snacks in the afternoons.

SummerTour is sponsored by the Tri-County Bicycle Association (TCBA) of Lansing, MI and is open to all capable interested bicyclists. You need not be a member of any organization to participate. The first **150** entries will be accepted.

Dear TCBA/DALMAC grant committee members:

You awarded Kids Repair Program a grant for summer 2018. We greatly appreciate the award and wish to provide a report of the summer activities. Bike Camp sessions were very successful. The newly remodeled youth "shop area" provided a very organized place for the youth ages 10 to 17 to learn repairs in. All youth that began the weekly camp sessions completed the instructional period and "learned and earned" a bike to take home with a new helmet and new lock. The summer bike instructor was a junior from MSU and his field of study was in health. The summer instructor was assisted in the camp sessions with a class monitor. All total during the summer season, 56 youth went through the weekly sessions at KRP and an additional 15 youth went through an onsite session #10 camp week at an income based housing complex near KRP. This was provided free of charge this week to these youth since most youth are of low income and many refugees. During the summer, staff, volunteers and bike camp instructor held 4 Free Tune Ups. Three in the community and one at KRP near a large apartment complex where flyers were distributed to direct them to the Free Tune Up. Between the 4 Free Tune Ups nearly 60 bikes were fixed with repairs (sign up sheets available on request) and multiple minor repairs were provided such as seat adjustments, blowing up tires and other minor adjustments. (Pictures are provided).

The KRP van continued to pick up bike donations through the summer and exchanged bikes with another nonprofit, Share A Bike. All tools and parts ordered were from D & K. The shop manager and the Board worked together to order the needed items to make the camp successful with needed items for the campers and to also refurbish the donated bikes that are used in the camp for each youth to "learn and earn to take home".
